

IMPORTANT INFORMATION TO ALL MEMBERS OF THE IBEW CONSTRUCTION COUNCIL OF ONTARIO (IBEW-CCO) AFFLIATED LOCAL UNIONS



On December 6, 2011 CSA Standards, the National Electrical Trade Council (NETCO), the joint training arm of the Canadian Electrical Contractors Association (CECA) and the IBEW First District Canada, announced the formal recognition of the ECAO/IBEW-CCO solar PV training curriculum. (If you have not taken this course and wish to do so, please contact your local union).

WHAT DOES THIS MEAN FOR IBEW-CCO JOURNEYMEN ELECTRICIANS?

Journeyperson electricians who have completed the ECAO/IBEW-CCO solar PV training curriculum are eligible to take the CSA exam - Construction Electrician (NOC 7241) Solar Photovoltaic (PV) Systems Certified. To date this is the only Ontario course that meets the criteria required to write the exam.

WHO IS THE CSA CERTIFICATION PROGRAM DESIGNED FOR?

Journeyperson electricians installing and maintaining solar photovoltaic (PV) systems in Canada. CSA adheres to the ISO 17024 international standard for certifying bodies.

HOW DO I APPLY TO WRITE THE EXAM?

The process of applying for the certification and setting up an exam time is facilitated primarily by email. The test is administered at CSA approved computer based testing centres (see bottom of page for application form website address).
